

INSTRUMENT OF GOVERNMENT

1. The name of the school is St Michael at Bowes Church of England Junior School.
2. The school is a Voluntary Aided school.
3. The name of the governing body is "The governing body of St Michael at Bowes Church of England Junior School.
4. The governing body shall consist of:
 - a. Two Parent Governors
 - b. One LA Governor
 - c. One Staff Governor
 - d. One Headteacher
 - e. Seven Foundation Governors
5. Total number of Governors 12.
6. The names of the foundation body or person entitled to appoint foundation Governors are.
 - 2 - appointed by London Diocesan Board for Schools
 - 2 - appointed by Parochial Church Council of St. Cuthbert's Church and St Michael at Bowes Church
 - 1 - appointed by East Haringey Deanery Synod.
7. (a) the holder of the following office shall be a foundation governor ex officio: incumbent of St Cuthbert's Church.

(b) The Archdeacon of Hampstead shall be entitled to appoint a foundation governor to act in the place of the ex officio foundation governor whose governorship derives from the office named in (a) above, in the event that that ex officio foundation governor is unable or unwilling to act as a foundation governor, or has been removed from office under regulation 20(2) of the Regulations.
8. (a) the holder of the following office shall be a foundation governor ex officio: Team rector of St Michael's Wood Green or his representative

(b) The Archdeacon of Hampstead shall be entitled to appoint a foundation governor to act in the place of the ex officio foundation governor whose governorship derives from the office named in (a) above, in the event that that ex officio foundation governor is unable or unwilling to act as a foundation governor, or has been removed from office under regulation 20(2) of the Regulations.
9. The Archdeacon of Hampstead shall be entitled to request the removal of any ex officio foundation governor and to appoint any substitute governor.

10. Ethos of the School.

Recognizing its historic foundation, the School will preserve and develop its religious character in accordance with the principles of the Church of England and in partnership with the Church at parish and diocesan level.

The School aims to serve its community by providing an education of the highest quality within the context of Christian belief and practice. It encourages an understanding of the meaning and significance of faith and promotes Christian values through the experience it offers to all its pupils.

11. This Instrument of Government comes into effect on 2 May 14.

12. A copy of the instrument must be supplied to every member of the Governor Body (and the Headteacher if not a Governor), any trustees and to the appropriate religious body.

13. This Instrument was made by order of Enfield Local Education Authority, using the Common Seal of the Mayor and Burgesses of the London Borough of Enfield which was hereunto affixed in the presence
